STUDENT PARKING POLICY

Students are permitted to park on school property during the school day under the following conditions and regulations:

- ✓ Students are permitted to park only in the south parking lot utilizing the end closest to the Technical Building.
- ✓ Student parking is permitted nowhere else on the campus except as provided elsewhere in this policy.
- ✓ Students are required to obtain a parking permit for their car and must display it at all times while parked on school property.
- ✓ Students may not permit another driver to use their parking tag.
- ✓ **Cost of replacement parking tag is \$15.00.**
- ✓ Students parking without authorization are subject to the following penalties:
 - First Offense: 2 demerits, 2 detentions, 60 day restriction from parking at school.
 - Second Offense: 4 demerits, 4 detentions, 1 year restriction from parking at school.
 - Third Offense: 6 demerits, 6 detentions, permanent restriction from parking at school.
- ✓ Students having their driving privileges suspended for any reason must ride to or from school with parent or on the school bus. Parking off campus and walking to school are not permitted. Additionally, cars are subject to towing at the owner's expense, and the driver is subject to legal prosecution.
- ✓ Students falsifying applications are subject to the provisions of the Discipline Policy and to having parking privileges revoked for extended periods of time or permanently.
- ✓ Single day parking tags may be obtained in advance for students needing to park on school property on a particular day only. They are valid only for the particular day. The principal has the authority to limit the frequency of issue of single day permits.
- ✓ Students may not enter/exit school property using the elementary entrance at school arrival/dismissal time.
- ✓ Driving Violations, as listed in the student handbook, will result in a suspension or loss of driving privileges. For a Category I Infraction, students will receive a minimum of a one-week suspension of driving privileges. For a Category II Infractions, students will receive a minimum of a 30-day suspension of driving privileges. Repeat violations may result in permanent suspension of driving privileges.
